Dr. Doyle presented changes approved by the TXPHP Governing Board made to the TXPHP drug testing program, including the completion of a pilot of Recovery Trek's PROOF PEth and nail testing and after reviewing the outcomes of the pilot. Based upon those outcomes, TXPHP GB is recommending that TXPHP extend the option of collecting blood and nail specimens using the PROOF Peth system for all TXPHP participants.

Dr. Doyle also discussed the PHP Governing Board's recommendation that the program begin a pilot to study the PROOF DNA urine testing system.
